

Personal data are processed by the European Investment Fund ("EIF" or "**Controller**") in accordance with Regulation (EU) 2018/1725 on the protection of natural persons with regard to the processing of personal data by the Union institutions, bodies, offices and agencies and on the free movement of such data, as such regulation may be amended from time to time.

1. **Legal Basis**

Explicit consent captured through an ad hoc document to be signed by the concerned individuals

2. **Data Subjects**

Selected EIF staff members with authority to sign contracts on behalf of EIF. Selected authorized signatories of EIF's clients

3. **Purpose**

Providing selected EIF staff members and selected authorized signatories of EIF's clients with qualified electronic signature in order to sign contracts electronically following their identification via video transmission.

4. **Data Categories**

- Audio and video recordings of the persons to be identified
- Surname, Name
- Address
- Phone number
- E-mail address
- Data of personal identity documents (in particular, passport number, type of identification document and the country which issued the document)

The purpose, the scope and type of data processing are as follows: online identification of persons and electronic handling of contract signing.

5. **Data Recipients**

IDnow GmbH is a German company based in Munich. It provides, among others, a service with which signatories are able to be identified via an online video chat, allowing them subsequently to e-sign a document.

6. **Data Retention Period**

The recordings will be kept for five years.

7. **Rights of Data Subject**

- Data Subjects have the right to obtain from the controller confirmation as to whether or not their personal data concerning are being processed, and, where that is the case, access their personal data by contacting the Controller (info@eif.org) or through the EIF DPO (dpo@eif.org) and they will receive a response without undue delay (**right of access**);
- Data Subjects have the right to obtain from the controller without undue delay the rectification of any inaccurate personal data concerning them (**right to rectification**).
- Data Subjects have the right to obtain from the controller the erasure of their personal data when they are no longer necessary in relation to the purposes for which they were collected (**right to erasure**);
- Data Subjects have the right to obtain from the controller restriction of processing when (i) they contest the accuracy of their personal data, (ii) the processing is unlawful, (iii) the controller no longer needs the personal data for the purposes of the processing or (iv) they

have objected to processing, pending the verification whether the legitimate grounds of the controller override theirs (**right to restriction of processing**);

- Data Subjects have the **right to object**, on grounds relating to their particular situation, when the processing of personal data is unlawful;
- Data Subjects have the right to receive from the controller their personal data in a structured, commonly used and machine-readable format and transmit those data to another controller without hindrance from the controller to which the personal data have been provided (**right to data portability**);
- Data Subjects have the **right to withdraw his or her consent** at any time. The withdrawal of consent shall not affect the lawfulness of processing based on consent before its withdrawal
- Data Subjects may lodge a complaint to the European Data Protection Supervisor (www.edps.europa.eu) at any time (**right to lodge a complaint**).
